## GREENFIELDS BETWEEN HOOK & NEWNHAM

The green fields separating Newnham from Hook are in Hook Parish (Hart District) and are supposed to be protected under Hart's Local Plan as the 'Hook Newnham Local Gap'. This extends from the existing limit of Hook's housing (Hook's settlement policy boundary) to the Newnham boundary. Hart doesn't have an up-to-date Local Plan in place, but 'Saved Policies' remains relevant.

Saved Policy 5.2 Conservation 21 Local Gaps: 'Development which would lead to the coalescence or damage the separate identity of neighbouring settlements will not be permitted in the following local gaps... [incl] Hook to Newnham.'

Hart District Council has twice refused a development of 48 houses within the Local Gap and the developer has appealed against the decision for the first application 14/00867/MAJOR.

Hart's argument is that, looking forward – now Hart has a stronger housing land supply – the further precedent set by allowing this Appeal would be too damaging to be justifiable.

If this development is allowed by the Inspector then the Local Gap policy is weakened – across Hart and for the fields between Hook and Newnham. There is potential for the remaining Hook Newnham Local Gap to be eroded until it becomes meaningless.

**Appeal APP/N1730/A/14/2226609 by Charles Church (Southern) Ltd against Refusal of Planning Permission 14/00867/MAJOR by Hart District Council for 48 homes at Land of Hop Garden Road**

**The Appeal will be heard at Hart Civic Offices in Fleet on 12th May.**

**The Inquiry is scheduled to start at 10am on the Tuesday and continue for the next two days. Schedules including times for lunch and closing will be announced by the Inspector on the first morning.**

**Hart District Council, Hook & Newnham Parish Councils and Hook Residents' groups are all strongly fighting this Appeal and are looking for support.**

**If Hook and Newnham residents could please attend the start on the 12th – but also pop in at any time on any day for as short or long time as they like – this will demonstrate to the Inspector the strength of local feeling regarding maintaining the separate identities of Hook and Newnham Villages for the long term.**

### Hook Neighbourhood Plan

Hook is developing a Neighbourhood Plan (NP) which for the future will help influence where and how development happens. Newnham Parish residents will be invited to respond to specific consultations. ### Hart's Emerging Local Plan SHLAA\* site S173

\*Strategic Housing Land Availability Assessment

**The site isn't new, it was put forward to the previous (failed) Draft Local Plan but not selected.**

**Hart is due to consult this autumn on the new Plan and is required by the Inspector to find in excess of 4,000 new homes over and above those previously allocated.**

**Allowing the Appeal for the Land off Hop Garden site on 12th May is likely to increase the feasibility of S173 for development.**

**The Inspector must take all submissions into account whether relating to policy or local knowledge-based evidence. How much weight he gives to each is a matter for him but accumulated evidence of local concern for the Site and the Local Gap can have a positive impact.**



## SOLVE

### Save Our Loddon Valley Environment



Clive Pinder has resigned from his formal role with SOLVE in order to stand for election to the Borough Council in the Basing Ward. Clive was instrumental, along with a few others, in establishing SOLVE from its formation in 2009. Like Cllrs Cubitt and Godesen in the Basing Ward, he remains an active and passionate supporter of our goals. Our heartfelt thanks to Clive for his work with SOLVE.

As in previous elections, SOLVE supports candidates regardless of political party who demonstrate by their actions support for our aims to protect the Loddon Valley from over development.

### Local Plan

The latest draft of the Local Plan was accepted by the Full Council on 26th March. This represents a positive outcome for SOLVE after years of campaigning. It is disappointing that the

East of Basingstoke site (Pyotts Hill) still has 450 new homes planned. However, the overall result seems balanced and reflects the concerns that SOLVE and local residents had about development in the Loddon Valley.

This Revised version of the Local Plan will now go to a further public consultation in May and June. A public pre-hearing with the Planning Inspector is due to take place on 21 July 2015 with full public hearing sessions due in October/November 2015.

If changes to the Local Plan are made during the course of the Inspector's examination, then a further round of consultation will take place on proposed modifications, prior to any formal adoption in early 2016.

# LOCAL POLICING AGREEMENT

Letter from Daphne Taylor (Chairman Tunworth Parish Meeting)

**'Upton Grey and Candovers Ward Cllr Mark Ruffell and Edward Belcher from Tunworth Parish Meeting have been in discussions with Hampshire Constabulary and the following wording has been drafted by agreement for submission to the Police and Crime Commissioner. Both parties wished for all pledged donors (individuals and Parish Councils) and potential donors to see the wording prior to its submission.'**

'As you will know, there has been a three stage process in these discussions.

'The first stage was whether an agreement could be reached in principle. The answer was 'yes' and PC Reid has continued as the dedicated Beat Officer past the initial deadline of 1st April while the detail of the agreement has been discussed.

'The second stage has been discussing the detail which is now at an end and we are hopefully moving to the third stage which is implementation. We will be discussing with Hampshire Constabulary the best method for payment and this may include setting up a charitable trust.

'There will be a renewed request for funding once these matters have been resolved. The detail of the agreement proposal is set out below.

'Thank you for your continued support.'

## AGREEMENT FOR THE RECEIPT OF GIFTS

PURSUANT TO SECTION 93 OF THE POLICE ACT 1996 (AS AMENDED)

### Parties

**Residents of the Beat Area known as Upton Grey and the Candovers.**  
(Hereinafter referred to as the 'Donator')

**The Police and Crime Commissioner for Hampshire**  
(Hereinafter referred to as the 'Recipient')

A gift of £60,000 per annum for a three year-period commencing on 1st May 2015. It is agreed by the Parties that the Donator will donate the sum referred to above and the Recipient agrees to receive it on the following terms:

- (1) This donation funds a Police Constable as a dedicated beat officer for the beat area known as Upton Grey and the Candovers which includes the area covered by the Upton Grey and the Candovers Ward and the Parishes of Dummer, Mapledurwell & Up Nately, and Newham.
- (2) The donation includes the sponsorship of a standard marked 4x4 police response vehicle for the use of the dedicated beat officer when on duty and in connection with his/her duties. It is understood by the parties that there may be exceptional policing need when this vehicle may need to be used by other Police Officers when the dedicated beat officer is on duty. This vehicle will be available for use by other Police Officers when the dedicated beat officer is on rest days or on annual leave.
- (3) There is no expectation on the part of either Party that the Agreement will in any way interfere with the Chief Constable's operational independence in respect of the deployment and duties of this dedicated beat officer, who is and will remain a member of Hampshire Constabulary. The same expectation applies to the operational use of the sponsored police response vehicle and the operational requirement to redeploy this vehicle in the event of an exceptional policing need elsewhere.
- (4) The Parties agree that this agreement should be reviewed after six months and thereafter on an annual basis. This agreement can be dissolved by mutual consent or with a period of notice by either party of not less than six months.

Dear Residents,

I am pleased to report a reduction in reported crime for the area of this magazine

### Villager Printed Copies?

As *Villager* editor I have been asked to consider whether paper copies delivered door-to-door are still required – in this electronic age etc.

To start a consultation process, Newnham Parish Council put this question to residents at its Parish Assembly on April 23rd comprising 33 residents plus guests, plus councillors.

I was actually surprised that the show of hands for those who wanted the paper copies to continue appeared unanimous – though I do appreciate those at the Assembly were those likely to be engaged to read the *Villager*. However it was an informative starting point – the message was that actually having both a printed copy and an emailed pdf was good.

Dear Friends

Election time draws ever closer and, certainly as I write, there is no clear indication as to who will form our next parliament and move into No 10. I must admit that I am not really a Party Political Person! I always use my vote, I consider that a duty and a privilege and I urge every one of you to do the same. But I am bewildered by all the pledges and promises that are made. How can I tell if they are achievable? How can I understand the financial intricacies of the health service, the housing market and the armed forces? But I am truly grateful that there are people out there – indeed a number of you live in my parish – who care enough to have a vision for the well-being of our community and our country and who have the skills and the courage to speak out and work hard to make this a good place for everyone to live in. I wouldn't be in your shoes for 'all the tea in china' as they say, having to take all the brickbats as well as the plaudits. But then you probably wouldn't want to be a vicar!!

We've had our own elections within the church in the last month at our Annual Parochial Church Meeting. It was far more predictable than the General Election, none of the positions were contested, but our churchwardens and PCC members for 2015/16 are now in place and I am very grateful to them for taking on these positions in church leadership. They share with me responsibility for the whole mission of the church – pastoral, evangelistic, social and ecumenical – and in that capacity are now looking at the life and work of our parish in the light of the Bishop's strategies and vision. Historically of course the Church and individual Christians have always been involved in politics. The provision of education and health care, better conditions in factories and prisons, and the abolition of slavery were all pioneered by the Church, because of concern for the quality of life and the flourishing of all God's people. Too often today we limit our faith to the personal relationship we each have with God whereas the command to 'love thy neighbour' demands that we look outside ourselves and reach out into the world. We are called to be 'agents of social transformation' because that is exactly what Jesus was all about: demonstrating loving faith at work in our villages and our country and across the world, bringing God's love and justice and peace to all his people.

So I may not be a Party Political Person but I shall certainly be thinking about these things and using my vote on May 7th. I hope you will be too.




